Terms and Conditions

I) Technical requirements.

- 1) The firm should be in the business of destruction of contraband/expired/seized/ confiscated goods or similar work, (proof of documents has to be submitted).
- 2) The bidder should be registered with the jurisdictional GST Office and any other registrations required as per the existing Laws relating to his business.
- 3) The bidder should have three years' experience in carrying out similar work. He should enclose proof for having executed such works along with satisfactory performance certificate.
- 4) The bidder should not be debarred from any Government/PSU for the similar work, an undertaking should be submitted.
- 5) The bidder must submit valid PAN card copy.
- 6) The firm must have license from the concerned pollution control committee/ state Pollution Control Board and has to be produced in original for verification as and when required.
- 7) The firm must have their destruction site in **Gujarat**.

Financial Terms:

- 1) The rates may be quoted on collectively on the basis of <u>Rupees per Metric Ton.</u>
- 2) The rates must include all types of charges and applicable taxes(including GST)
- 3) The rates quoted should be net and no discount free service/ offers quoted in the quotation will be considered.
- 4) No advance shall be paid and a consolidated bill will be submitted after the completion of the work for payment. The bills will be countersigned by the relevant officers before submitting the same for financial sanction. The bill will be cleared within a reasonable time. However, in case of any unexpected delay, the contractor should be in a position to offer a credit facility for the period TDS and GST will be made as per law.

General Terms and Conditions/

- 1) The Technical bid will be opened first and the financial bids of only those who have qualified in the Technical Bids will be opened.
- 2) Transportation of the subject goods from <u>present place of storage to the incineration facility would be done by the Commissionerate office, but the contractor has to provide a notice period of two days for the delivery of the goods.</u>
- 3) The destruction of the said goods is to be carried out as per prevalent guidelines/instructions issued by the Central/State Government.

- 4) The whole process of the destruction is to <u>be photographed/video</u> recorded and in presence of the officers of this office.
- 5) The contract will be <u>valid for the present consignment/goods only:</u> but the same could be terminated without assigning any reason by this office any time.
- 6) The Technical bid should be as per Annexure -I and Financial bid as per Annexure-II otherwise vendor will be considered disqualified.

Amendment of Tendering documents

- i. Before the deadline for submission of Tenders, the CGST Kutch Commissionerate may cancel whole part of tender or modify the Tendering documents by issuing addenda.
- ii. Any addendum thus issued shall be part of the Tendering documents and shall be uploaded on website www.cbic.gov.in/____.
